F () SCHOOL OPERATES AS AN ACTIVITY OF A CHURCH, PARISH OR OTHER RELIGIOUS BODY

The undersigned certifies that the communication services or facilities furnished or to be furnished to the institution will be paid for from the funds of the institution and are for the exclusive use of the school. The school, operated as an activity of the church, parish or other religious body exempt normally has a regularly enrolled body of students in attendance at the place where its educational activities are regularly carried on, and has as its principal function the providing of formal education.

G () NONPROFIT EDUCATIONAL ORGANIZATION

The exempt organization normally maintains a regular faculty and curriculum, normally has a regularly enrolled body of students in attendance at the place where its activities are regularly carried on, and has as its principal function the providing of formal education.
