Enclosed are the Fiscal Year 2018 final closing statements as required by Section 35-6-1 (8) (c) of the Rhode Island General Laws.

The Fiscal Year 2018 Comprehensive Annual Financial Report (CAFR) has been issued with the required independent auditor's report dated December 28, 2018. I am pleased to inform you that the independent auditor's report expressed unmodified opinions on the audited financial statements within the CAFR.

The closing surplus increased from \$45.5 million, reflected in the preliminary report of September 1, 2018, to \$52.5 million in the final audited report. Please see pages 29 and 30 for information on the changes.

The Fiscal 2018 CAFR also includes the Government Finance Officers Association *Certificate of Achievement for Excellence in Financial Reporting* awarded for the Fiscal Year 2017 CAFR. This award reflects the State's continued commitment to ensuring that financial information, which meets generally accepted accounting principles, is reported on a timely basis.
