# February Updates

## Important Updates Impacting the Grant Management System:

### 2023 Monthly Calls with State Agencies – Second Monday of the Month.

- 1) **New grants regulation:** The regulation is currently in the 20-day period required by the Secretary of State before it becomes enacted. **220-RICR-20-00-2** is expected to take effect next week, on/about February 20th.
- 2) **FFATA:** The Grants Management Office conducted a training and information session related to FFATA reporting requirements for subawards. The slide deck is available on our FFATA info page: <https://controller.admin.ri.gov/grants-management/ffata>
- 3) **Application Deadlines:** For competitive solicitations, the application process and deadlines must be the same for all applicants. If an applicant is unable to meet the deadline for any reason, including technical, the agency must either a) extend the deadline for all, or b) refuse late applications.

# New Business # 1 – DTA Form

## Non-Competitive (Direct to Award) Subaward Justification Form

1. Form available on [Agency Resources](#) page
2. Required for non-competitive DTA subawards only, per new grants regulation at 220-RICR-20-00-2.6.2(B)
3. Similar in concept to sole/single source justification
4. Process:
  - Complete, sign, submit via [User Support](#) 21 days prior to publication of a solicitation in GMS
  - GMO to review and respond in writing within 14 days (typically sooner). Approvals will be signed and returned to Agency.
  - Agency to proceed with solicitation after receipt of signed approval.

# Highlights of New Grants Reg - Agencies

- Use GMS for all subawards
- Competitive subawards: Effective 7/1/23
  - required content for solicitations/funding opps
  - public notice - post funding opportunity/solicitation for 21 days
  - preapp conference – optional
  - application review
    - must have 3 reviewers if awards > \$30k
    - agency picks reviewers
  - subaward decisions – if agency modifies/rejects reviewers' recommendations, must document before issuing tentative notices of award
- Non-competitive subawards: Justification form to be reviewed and approved by GMO.
- Risk Assessment
  - Use annual org registration if award \$30k+. DMAH's have access
  - Federal factors from 2 CFR 200..., plus state monitoring/audit results and credible allegations of fraud, waste, etc.
- Subaward Issuance: Must use subaward agreement template

# Highlights of New Grants Reg - Others

- Reviewers
  - Confidentiality
- Applicants/Subrecipients
  - Public UEI, OSP, Annual Org Reg
  - Must use GMS to apply
  - Written subaward agreement
  - “Receipt of the fully executed Subaward Agreement in GMS is a threshold requirement for payment requests to be submitted. Costs may be incurred from the Performance Period Start Date. Unless "pre-award costs" are explicitly authorized in a Subaward Agreement (Subaward Identification Information section), no costs incurred prior to the Performance Period Start Date are eligible for payment or reimbursement.”
  - Payment Requests – backup required
  - Reporting via GMS
  - Monitoring happens
  - Submit closeout docs in GMS within 90 days

# Tips for Reconciling GMS Transaction Data

- Compare reports:
  - RIFANS: RI Register 1- Federal Transaction Register by Account
  - eCivis: Enterprise Budget Report, filtered for your grant(s)  
navigate to *Report > Enterprise Reporting > Budget Report*
- GMS Data
  - Only transactions with a RIGID
  - Cash Basis
- Key Dates in Enterprise Budget Report
  - transPostDate. This matches the field you see in eCivis. This software is not customized for us, so this is their system fieldname. It is the equivalent of RIFANS Cash Date.
  - physicalPostedDate. Directly from RIFANS.
  - postedDate. Directly from RIFANS.
  - cashDate. Directly from RIFANS.

# Troubleshooting Grantee Transaction Data

Reasons your data may not reconcile:

1. Transactions haven't been tagged with a RIGID. Use Register 7/8 to add RIGIDs. See ["GMS – RIFANS Training Manual."](#)
2. The GMS budget is unlocked. Transactions won't flow over until your grant or subproject budget is locked. Before locking a budget, add rows for any naturals likely to be used.
3. Transactions have been tagged, but the natural isn't in the GMS budget. A person with DMAH access will need to unlock the budget, add line items for the naturals, and relock the budget.
4. Transactions have been tagged with the wrong RIGID. If you are recycling the line sequence, make sure it is associated with at least 2 open grants/subprojects in GMS. Then use Register 7/8 to revise RIGIDs.
5. The line sequence is not entered in the *Internal Grant Name* field for the grant/subproject. See ["Correcting an Invalid Line Sequence in eCivis."](#)
6. Budget Settings for Match/Cost Share and Indirect Costs have been changed. Reset to "Not Applicable."

# **UPDATE:** Guidance on Handling Deleted RIGIDs

- Deleting a grant, project, or subproject in eCivis deletes the associated RIGID.
- Deleted RIGIDs are not available for use in RIFANS, so you **cannot journal transactions off a deleted RIGID to a new one.**
- Close grants. Don't delete them.
- If you must delete, untag the RIGID from all transactions **before** you delete a grant, project, or subproject.

**Please reach out to the GMO before deleting a grant, project, or subproject in eCivis. The GMO will work with your agency on alternatives to deleting.**

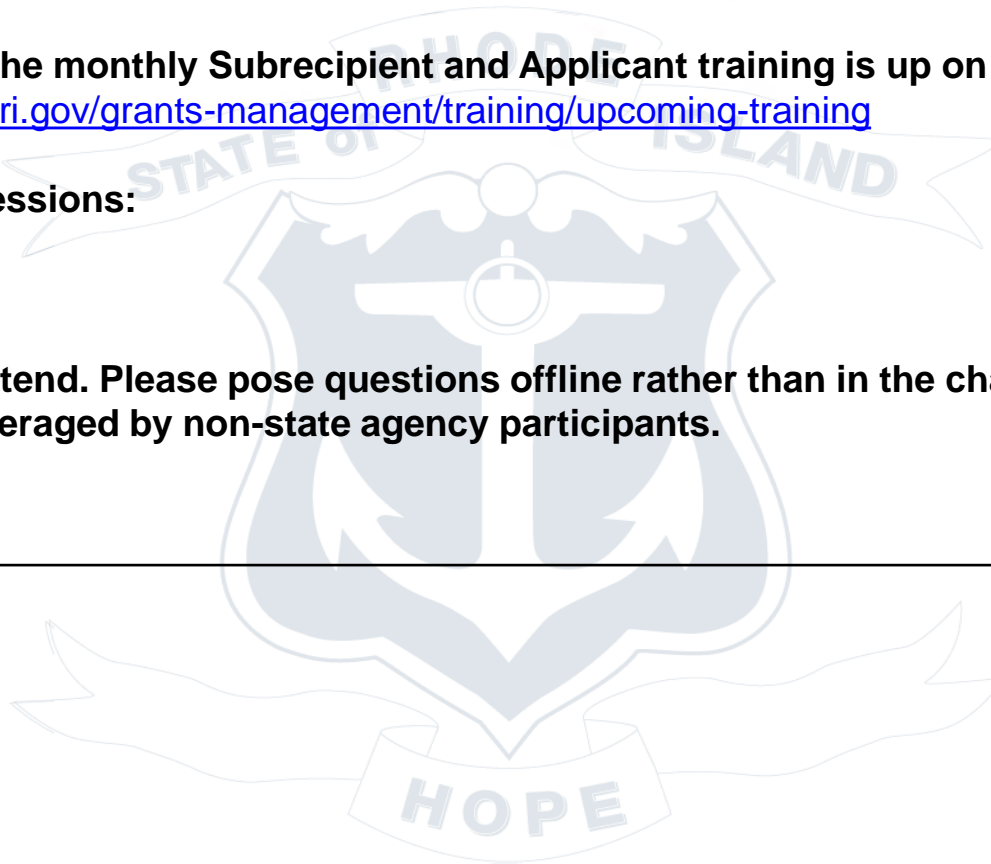
