RE: FY 2024 – PRELIMINARY UNAUDITED CLOSING STATEMENTS

Enclosed for your review are the Fiscal Year 2024 preliminary unaudited closing statements as required by Section 35-6-1 (a) (10) of the Rhode Island General Laws (RIGL).

For your convenience, below is a summary of results reflected in these preliminary statements:

- The General Fund surplus balance is \$291.7 million. This is after transfers of \$173.4 million to the Budget Reserve and Cash Stabilization Account and \$60.6 million in other fund balance adjustments.
- Of the \$291.7 million General Fund Surplus, the general assembly allocated \$279 million for expenditures during fiscal year 2025.
- The budget reserve and cash stabilization account ended the year with a balance of \$289 million after a transfer of \$155.5 million to Rhode Island Capital Plan Fund.
- The Supplemental Budget Reserve Account received a \$55 million special appropriation. Additionally, a one-time retroactive repeal of the transfer to the supplemental budget reserve resulted in \$6.5 million being returned to General Fund from the Supplemental Budget Reserve Account. (1)
- General revenues were \$5.1 million less than estimated.
- General Revenue expenditures were \$69.2 million less than budgeted.
- FEMA related reimbursements in Fiscal Year 2024 related to Fiscal Year 2023 expenditures were \$23.8 million.

(1) Repeal of FY 23 New Rainy Day Requirement:

Subsequent to the Fiscal Year 2025 budget article, bill 2024-H7927A (H7927A.pdf (rilegislature.gov)) passed which enacted a one-time retroactive repeal of the transfer to the supplemental budget reserve relative to Fiscal Year 2023 surplus (\$6.5 million). We reversed the transfer of the additional reserved amount of \$6.5 million during June 2024. This is reflected in the summary information above.
